### **Instruction to bidders regarding e-tendering process:-**

1. The interested bidder can download the NIT/bidding document from the website [www.jktenders.gov.in](http://www.jktenders.gov.in) and [www.maavaishnodevi.org](http://www.maavaishnodevi.org).
2. To participate in bidding process, bidders have to get (DSC) “Digital Signature Certificate” as per information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. Bidders can get above mentioned digital certificate from any approved vendors.
3. The Bidders, who already possess valid (DSC) Digital Signature Certificates, need not to procure new Digital Signature Certificate.
4. The Technical Bids shall be opened online.
5. Financial Bids of bidders shall be opened online which shall be communicated separately.
6. The bidders have to submit their bids online in electronic format with Digital Signature. The bids cannot be uploaded without Digital Signature. No Proposal will be accepted in physical form.
7. Bids will be opened online as per time schedule mentioned in the e-NIT.
8. Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with bid.
9. Shrine Board will not be responsible for delay in online submission of bids whatsoever reasons may be.
10. All the required information for bid must be filled and submitted online.
11. Bidders should get ready with the scanned copies of cost of documents & EMD as specified in the tender documents.
12. The details of cost of documents, EMD specified in the tender documents should be the same, as submitted online (scanned copies) otherwise bid will not be accepted.
13. Bidders are advised to use “My Documents” area in their user on <http://jktenders.gov.in>, e-tendering portal to store important documents like Balance Sheet, GST Registration Certificate, Tax Clearance Certificate, IT Certificate, Manufacturers authorization and other related documents etc., and attach these certificates as Non-Statuary documents while submitting their bids.

### 1. REQUIREMENT:

For and on behalf of Shri Mata Vaishno Devi Shrine Board, through Chief Executive officer, (herein after referred as SMVDSB), e-Tender under two bids system is invited from the reputed professional manufacturers / distributors / dealers / authorized suppliers dealing in Supply of Summer Seasoned B – Class Bricks & Brick Tiles to Shri Mata Vaishno Devi Shrine Board, Katra F.O.R. Engineering Store, Banganga, Katra / Engineering Sub-Store, SMVDIME, Kakryal / Units of SB at Jammu for a period of One year or till the finalization of Fresh Rate Contract whichever is later.

- Bidders must ensure to upload scanned copies of all necessary documents **i.e., PAN, GSTIN, Tender Fee (DD), EMD (CDR/FDR), Registration, Manufacturer Certificate / Authorized Distributor / Dealer Certificate, Income Tax Returns, IS/ISO Certificate and other documents as mentioned in the e-NIT.**
- Hardcopy of the Technical Bid Documents, EMD (in original) and 02 samples each of Bricks and Brick Tiles shall be deposited in the office of Chief Executive Officer, Purchase Department, SMVDSB, Central Office, Katra – 182301 before the opening of the technical bid without which the offer submitted by the firm shall not be considered.
- **It shall be noted that if any tenderer did not upload / enclose the CDR/FDR of stipulated amount or furnished CDR/FDR of an amount less than the stipulated amount, as mentioned in the e-NIT, the bid / tender submitted by the bidder shall be rejected out-rightly and the rates of the said bidder shall not be considered even after opening of tender.**
- **The tenderers furnishing the CDR for an amount less than the stipulated amount mentioned in the Tender quoting the exemption as Small Scale Industries or any other reason shall not be entertained and the bid shall be out-rightly rejected.**
- Submission of the Hardcopy of the financial bid leads to the rejection of the e-bid.
- Only hardcopy of the uploaded Technical bid Document, Tender Fees EMD and samples should be deposited in the office of Chief Executive Officer, Purchase Department, SMVDSB, Central Office, Katra – **182301 on 06.12.2023 upto 03:00 PM.**

### 3. PROCEDURE FOR SUBMISSION OF TENDER:

The Tenderers are required to submit their tenders under 2 bids system with Cover-I (Technical Bid) and Cover-II (Price Bid).

#### A. Technical Bid

- i. Non Refundable Tender Fee of Rs. 500/- (Rupees Five Hundred Only) either in the form of Demand Draft in favour of Chief Accounts Officer, SMVDSB, Katra or through NEFT which shall be deposited in the official account of SMVDSB Account No. 0235040500001804, IFSC – JAKA0KATTRA (“0” Zero) without which the tender/offer shall be rejected out rightly. In case of NEFT transfer, the bidder shall mention UTR No. in the prescribed Technical Bid Form at Annexure-‘A’.
- ii. **Scanned copy of the EMD amounting to Rs. 50,000/- (Rupees Fifty Thousand Only) in the shape of CDR/FDR/TDR** pledged to Chief Accounts Officer, SMVDSB, Katra or the same shall be deposited in the official account of Shri Mata Vaishno Devi Shrine Board Branch J&K Bank, Katra, Account No. **0235040500001804, IFSC – JAKA0KATRA (in IFSC Code JAKA0KATRA – 0 stand Zero)** without which the offer shall be rejected outrightly. The bidder shall have to mention UTR No. in the prescribed Technical bid Form at **Annexure – “A”**.
- iii. **Experience / Past Performance:**
  - a. The Bidder (manufacturer / Authorized supplier) should have regularly for at least last three years ending 31<sup>st</sup> March of the previous financial year, manufactured / supplied the material mentioned in the e-NIT with the same or higher specifications as per Annexure – A (**supply orders to be attached.**)
  - b. The bidders should have manufactured or supplied at least 60% of the estimated quantity of the product in at least one of the last five (05) years ending 31<sup>st</sup> March (**supply order to be attached**).
- iv. **Capability, Equipment & Manufacturing Facilities:**
  - a. The bidder must have an annual capacity to manufacture or supply at least 60% of the estimated quantity (**self certificate to be attached**).
- v. **Financial Standing under all conditions:**
  - a. The average annual financial turnover of the “The Bidder” during the last three years, ending 31<sup>st</sup> March of the previous year should be 60% of the estimated cost of the product as per the annual audited balance sheet and profit & loss account of the relevant period duly authenticated by a Chartered Accountant. Copies of the ITRs for the last three (03) years to be attached. (**The turnover of the sister concern firms / subsidiaries shall not be considered by Shrine Board**).
  - b. Bidder (Manufacturer / Authorized supplier) should not have suffered any financial loss for more than one year during the last three (03) years ending on the 31<sup>st</sup> March of the previous year (**copies of audited Balance Sheet to be enclosed**).
  - c. The Net Worth of the Bidder (Manufacturer / Authorized supplier) should not be negative on 31<sup>st</sup> March and also should have not eroded by more than 30% (thirty percent) in the last three years, ending on 31<sup>st</sup> March (**copies of audited Balance Sheet to be enclosed**).
- vi. Self-attested copy of GST Registration Certificate & PAN.
- vii. Participating firm / bidder shall have to submit 02 samples each of Brick & Brick Tile along with the hardcopy of the uploaded documents.
- viii. Self-attested Manufacturing Unit Registration Certificate / Authorized Distributor / Authorized Dealer Certificate to be enclosed.

- ix. IS / ISO Certification of the material to be supplied.
- x. Quality & Test Reports of the Bricks & Brick Tiles to be enclosed.
- xi. Copies of Income Tax Returns for the last three years.
- xii. Tender Document duly signed and stamped conforming the acceptance of Terms and Condition mentioned in the e-NIT.
- xiii. Declaration Certificate as enclosed at **Annexure – B**.
- xiv. No Deviation certificate as enclosed at **Annexure – C**.
- xv. Bidder's details as per **Annexure – D**.

#### **B. Financial Bid (BOQ):**

- i) Price bid shall be as per BOQ & has to be submitted **online only**. Submission of the Hardcopy of the same tantamount to rejection of the bid submitted online.
- ii) The price bid should be absolute and unconditional.
- iii) Conditional bids shall be rejected.
- iv) The price bid shall be opened in respect of the bidders who have qualified in the technical bid. Rates are required to be quoted strictly as per prescribed BOQ / item of works.

#### **4. Quantity:**

The approx. annual required quantity mentioned in the e-NIT is indicative in nature and may increase or decrease depending upon the requirement of SMVDSB from time to time during the Rate Contract Period.

#### **5. RATES:**

The rates quoted must be F.O.R. Non Engineering Store, Banganga, Katra / F.O.R. Sub Store, SMVDIME, Kakryal / Units of SMVDSB at Jammu inclusive of GST, loading, unloading, proper stacking, labour charges etc.

The successful bidder shall have to mention the GST No. 01AAETS9822J1ZC of Shri Mata Vaishno Devi Shrine Board Katra while raising their bill of supplies. While filing GSTR-I, the successful bidder shall classify the supply / Service made to Shrine Board under Business (B to B) Sales. The successful bidder shall also mention six digit HSN code of the material to be supplied. In case the successful bidder doesn't upload / mention the bill under B to B, the GST amount levied in the Bill shall not be paid. The successful bidder shall file GSTR 1 and 3B within the due dates prescribed under the CGST / SGST Act 2017 so as to enable SMVDSB to claim timely input credit. In case of default, interest @ 2% per-month of tax amount shall be charged and recovered from the defaulting supplier.

After the successful culmination of tender, if the approved bidder refuses to comply with the rate approval order and subsequently fails to comply the supply orders on account of any reason, the same bidder shall be debarred from further dealing with the Board for a continuous period of 03 years and the stipulated CDR/FDR of the bidder shall be forfeited.

The rate approval order shall be effective from the date of approval and shall remain in force for a period of **one year**. The successful bidder will have to supply the material against the supply orders issued from time to time by SMVDSB, during the rate approval period or till the finalization of Fresh Rate Contract whichever is later.

No escalation in the basic rate of item shall be allowed by SMVDSB during currency of Contract. If the rate of GST is increased/ decreased or a new tax is introduced or an existing tax is abolished or any change in interpretation or application of any tax occurs in the course of performance/evaluation of contract, which was or will be assessed on the bidder in connection with the performance of the contract, an equitable adjustment of the contract price shall be made to fully take into account any such change by addition to the contract

price or deduction there from as the case may be. However no escalation in the basic cost of the item shall be allowed during the currency of the contract.

If at any time it is established that successful tenderer has sold the items to any other Government /Semi-Government/ Private Hospitals/department/ Institutions at a lesser price, he shall be liable for reimbursement of the excess rates charged besides imposition of penalty. Also in case the printed rates are lower than quoted rates, then printed rates shall be payable.

## **6. RIGHT RESERVED BY SMVDSB**

- a) The Shrine Board reserves the right to split the demand among one or more qualified bidders at the approved rate after culmination of successful e-NIT.
- b) The Shrine Board reserves the right to reject, accept or prefer any tender in part or full at any stage if not in conformity to the specifications, terms & conditions mentioned in the e-NIT. Shrine Board also reserves the right to re-invite the tender at its sole discretion.
- c) The Shrine Board reserve the right to negotiate the quoted rates, terms and conditions with the lowest tenderer or any of the other tenderers on quality basis to ascertain the suitability of the acceptable offer.

## **7. SIGNING OF TENDERS:**

Each page of the Tender (Technical Bid) which is to be submitted in technical form shall be signed by the tenderer / authorized signatory of the company / firm, conforming the acceptance of the Terms and Conditions as laid down in the e-NIT document.

## **8. VALIDITY:**

The offer shall remain valid and open for acceptance for a period of **90 days** from the date of opening of tenders (Technical as well as Financial Bid), if the tenderer withdraws his tender before the expiry of the said period or makes any modifications in the terms and conditions of the tender, the earnest money/security deposited by the tenderer shall be forfeited without any notice and the firm shall be debarred from any further dealing with Shrine Board for a period of 5 years.

The rates quoted by the tenderers shall be valid for a period of **01 year** from the date of issuance of Rate Approval Order or till the finalization of fresh Rate Contract whichever is later.

## **9. PAYMENT:**

**No advance payments shall be made.** The payment of the supplied material shall be made on consignment basis after receipt and proper inspection at Engineering Stores, Banganga Katra / Engineering Sub Store, SMVDIME, Kakryal / Units of SMVDSB at Jammu within a period of 20 days from the date of issuance of G.R.

## **10. DELIVERY PERIOD:**

The successful tenderer shall have to deliver the ordered quantity within the time period mentioned in the subsequent purchase orders. The material shall be supplied immediately from ready stock from the date of placement of purchase order for it shall be expected from the successful tenderers(s) that they keep sufficient stock of the approved item(s) for immediate supply of the ordered item(s).

## **11. INSPECTION / LIFTING BACK OF REJECTED SUPPLIES:**

The material supplied shall be checked / inspected by the quality cell / inspecting team of Shrine Board and if found of inferior quality / defective, the same shall be rejected. The rejected material shall have to be lifted by the supplier at his own risk and cost within a week's time failing which storage charges @ 2% of the total value per day as may be deemed fit to the authority shall be levied.

In case the rejected supplies are not lifted within one month from the date of intimation, the material shall be auctioned without any correspondence with the firm.

## **12. PENALTY:**

In case the material is not delivered within the delivery period, the supplier is liable to penalty for the delay i.e. i) upto 07 days @ 0.5% ii) from 8th day upto 15th day @ 1% iii) from 16th day upto 22nd day @ 1.5% and iv) from 23<sup>rd</sup> day to 30<sup>th</sup> day @ 2% shall be imposed on each pending item as per the approved rate / quantity mention in the PO of the value of the pending supplies. Further delay shall attract additional penalty @1% every 10<sup>th</sup> day.

In case of incomplete supply received, an amount equal to 2% of the total value of non-supplied material shall be deducted from the due payment of the successful bidder.

## **13. FORCE MAJEURE:**

Any failure or omission to carry out the provisions of the order shall not give rise to any claim by one party against the other, if such failure or omission arises from an "Act of God" which shall include all acts of Natural Calamities such as fire, flood, earthquakes, hurricanes, pandemics or any pestilences or from civil strikes, compliances with any statute or regulations of the Government lock outs and strikes, riots, embargoes or from any other reasons beyond the control of the parties including the war (whether declared or not) Civil War or State of Insurrection.

## **14. ARBITRATION:**

In case of any dispute arising between the parties hereto relating to the supply of the Material and all matters connected therewith, both parties shall make every effort to resolve it amicably by direct informal negotiation. If, even after 30 days from the commencement of informal negotiation, the parties have not been able to resolve the dispute amicably, then such disputes / differences shall be resolved by arbitration as per The Arbitration and Conciliation Act, 1996.

- Either party may request other of its intention that a dispute be submitted to Arbitration and both the parties shall meet within 15 days from the date of receipt of such request, to select a sole arbitrator mutually for the resolution of dispute and venue/seat of Arbitration shall be at Jammu.

- In the event that the parties cannot agree upon the selection of the sole Arbitrator, either party or both of the parties may move an application before the Hon'ble High Court at Jammu, under the Arbitration and conciliation Act-1996, for the appointment of sole Arbitrator with seat/venue at Jammu for the resolution of disputes between the parties.

## **15. JURISDICTION:**

The Courts at Jammu, Katra / Reasi alone, shall have the jurisdiction with respect to subject matter of this e-NIT.



## **16. Other Terms and Conditions:**

- i) Bidders must ensure to upload scanned copies of all necessary documents **i.e.**, PAN, GSTIN, Tender Fee (DD), EMD (CDR/FDR), Registration, Authorized Manufacturer, Distributor / Dealer Certificate, Income Tax Returns, IS/ISO Certificate and other documents as mentioned in the Technical Criteria.
- ii) Participating firm / bidder shall have to submit 02 samples each of Brick & Brick Tile along with the hardcopy of the uploaded documents.
- iii) On the date of final issue of Letter of Award / Supply Order after successful culmination of tender, the rate of Public Sector Under Taking (PSU) shall be considered as a reference rate and if the rate of L-1 bidder is found above the prevailing rate of PSU, the bidder / L-1 firm shall have to supply the material at said PSU rate to SMVDSB (F.O.R. Katra).
- iv) The tenderer shall not be entitled to revoke or withdraw their tenders or vary or modify after its submission.
- v) SMVDSB reserves the right to split the demand among one or more qualified bidder at the approved rate of L-1 after culmination of the tender process. SMVDSB also reserve the right to negotiate the quoted rates, terms and conditions with the lowest tenderer or any other tenderers on quality basis to ascertain the sustainability of the accepted offer.
- vi) These terms and conditions will form an integral part of the Rate approval order / supply order with the successful tenderer(s), which the tenderer shall have to enter into with the SMVDSB.
- vii) The CEO / Addl. CEO, SMVDSB, reserves the right to terminate the rate approval order/ supply order during the period of its validity if found not in conformity to the terms and conditions.
- viii) **It shall be noted that if any tenderer / firm did not upload / enclose the CDR/FDR of stipulated amount or furnished CDR / FDR of an amount less than the stipulated amount, as mentioned in the NIT, the bid / tender submitted by the firm shall be rejected out-rightly and the rates of the said firm shall not be considered even after opening of tender.**
- ix) The tenderers furnishing the EMD for an amount less than the stipulated amount mentioned in the Tender quoting the exemption as Small Scale Industries or any other reason shall not be entertained and the tender shall be out-rightly rejected.
- x) Conditional, illegible, ambiguous tender(s) received after the stipulated date and time shall be out rightly rejected. **Furthermore, no increase in rates (of any sort) shall be entertained by Shrine Board during the rate contract or till the finalization of Fresh Rate Contract.**
- xi) No increase in rate shall be entertained by the Board during the currency of Rate Approval. However, any change in the taxation by the Govt. shall be considered by the Board and based on the reasonability of the rates, decision shall be taken at the discretion of Board.
- xii) After the successful culmination of tender, if the approved firms refused to comply with the rate approval order or supply orders on account of any reason, action under the ambit of terms and conditions of the e-NIT / Rate Approval Order shall be initiated against the same firm besides debarring the firm for a continuous period of 03 years including forfeiting of EMD.
