Rate should be NET inclusive of all taxes, having special discount to SMVDSB and the same shall be delivered at Engineering Store, Banganga, Katra within the period mentioned in the subsequent Purchase Order. ***However, Donations to Shri Mata Vaishno Devi Shrine Board, Katra are exempted from Income Tax under Section 80-G of the Income Tax Act.***
3. ***The rate quoted should be NET and valid for a period of 10 days from the date of Opening of quotation and should be valid for a period of Three Month from the date of issuance of Rate Approval Order / Purchase Order.***
4. You are requested to send your quotations by or before **04.12.2023 upto 05:00PM**, quotations after due date and time shall not be accepted.

5. **The participating firm shall have to submit prescribed test certificates as per FSSAI/BIS (IS5982 and IS498), without which the offer submitted online shall not be considered.**
6. Rate should be Net inclusive of all taxes, having special discount to SMVDSB (if any) and the same shall be delivered at Non Engg. Store, Banganga, Katra. The supplier has to mention the price of the material, CGST & SGST separately while raising the bills of supplies.
7. The quantities mentioned in the format are indicative in nature and can be increased / decreased substantively according to the requirement from time to time during the rate approval period.
8. Shrine Board Reserves the right to split the demand among one or more firms on quality basis to ascertain the suitability of the acceptable offer.
9. Shrine Board Reserves the right to cancel the RFIQ without any prior notice.
10. No Advance payment shall be made. The payment shall be made and after receipt and proper inspection of complete material at Non Engineering Store, Banganga.
11. The Shrine Board reserves the right to negotiate the quoted rates, terms and conditions with the lowest bidder or any of the other bidder on quality basis to ascertain the suitability of the acceptable offer.

On receipt, the material shall be inspected / checked by our Inspection Committee and if found of inferior quality/defective, the same will be rejected and the Board shall be at liberty to have the same procured from open market at the risk & cost of the supplier whereby the original supplier shall be liable to pay the extra cost, if any, involved in the process. The Competent Authority, however, may accept the replaced material within the delivery period if it conforms to the approved specifications.
13. In case of incomplete supply, an amount equal to 2% of the total value of work shall be deducted from the due payment of the supplier.
14. **The successful bidder shall have to submit the laboratory test report along with each consignment.**
