
The Quotations will be opened on the same day or any other day convenient to the authority. The representatives of bidders can attend the same, if desirous so.

5. The SMVDSB is at liberty to cancel the Order/Contract at any stage during the Contract Period in case of unsatisfactory performance by the Service Provider.
6. The Shrine Board reserves the right to cancel the RFIQ without any prior notice.
7. The Shrine Board reserves the right to reject, accept or prefer any Offer in part or full without assigning any reason whatsoever in this regard. The Shrine Board also reserves the right to re-invite the Quotations solely at its own discretion.
