Instruction to Bidders regarding e-Tendering process:

- 1. The interested bidder can download the e-NIT / bidding document from the website www.jktenders.gov.in&www.maavaishnodevi.org.
- 2. To participate in bidding process, bidders have to get (DSC) "Digital Signature Certificate" as per information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. Bidders can get above mentioned digital certificate from any approved vendors.
- 3. The Bidders, who already possess valid (DSC) Digital Signature Certificates, need not to procure new Digital Signature Certificate.
- 4. The bidders have to submit their bids online in electronic format with Digital Signature. The bids cannot be uploaded without Digital Signature. No Proposal will be accepted in physical form.
- 5. Bids will be opened online as per time schedule mentioned in the e-NIT.
- 6. Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with bid.
- 7. The SMVDSB will not be responsible for delay in online submission of bids whatsoever reasons may be.
- 8. All the required information for bid must be filled and submitted online.
- Bidders must attach scanned copies of all documents EMD as specified in the tender documents.

1. **REQUIREMENT:**

For and on behalf of SMVDSB, through its CEO, SMVDSB, e-Tender affixed with e-Stamps worth Rupees Six only, under Two Bids System are invited from the publishers / firms registered with the Federation of Publishers & Book-Sellers association of India for Rate Approval for the supply of Medical Books / Journals for SMVDIME, Medical College, Kakryal. 3. **ELIGIBILITY CRITERIA:**

- a) The tenderer should be registered with the Federation of Publishers & Book-Sellers Association of India. Necessary supporting documents must be uploaded / enclosed with the technical bid.
- b) The bidder shall have to provide the documentary evidence of a minimum of one (01) work / supply order amounting to tune of Rs. 10.00 Lakh or three (03) work / supply order amounting to tune of Rs. 5.00 Lakh each (preferably supported by the bills) for the supply of Books / Journals to any Government Medical College / Hospitals (to be enclosed with the Technical Bid).
- c) The bidder shall have to submit at-least **05 Satisfactory Service Certificates** at least 01 from J&K.
- d) Average Annual turnover of the bidder should be more than Rs. 8.00 Lakh for the last three financial years (2021-22, 2022-23 & 2023-24) as per the annual audited balance sheet and profit & loss account of the relevant period duly authenticated by a Charted Accountant (The turnover of the sister concern firms / subsidiaries shall not be considered by Shrine Board).
- e) The bidder must have sound financial background and a certificate from Chartered Accountant for positive net-worth be submitted for the last three financial years (2021-22, 2022-23 & 2023-24). Further, in case the final

accounts i.e. Profit & Loss, Balance Sheet for FY-2023-24 is under audit process, the bidder may attach the P&L, Balance Sheet for F. Y. 2020-21.

- f) The bidder should be an Income Tax Payee.
- g) The bidder must be an authorized distributer / dealer / supplier of leading publishers of the books / journals (attach documentary evidence).
- h) The bidder must attach / upload an affidavit on stamp paper duly attested by 1st Class Magistrate to the effect that:
 - i. The documents catalogue etc. enclosed with the e-tender are genuine and have not been tampered or fabricated.
 - ii. The firm has not been blacklisted in the past by any Govt/ Private institution of the country.
 - iii. If anything is found incorrect at any stage, the bidder shall be personally responsible for the same.
- i) The bidder must attach / upload the copies of following with bid document:
 - i) Pan card
 - ii) Membership certificate with the federation of publishers & book seller association of India.
 - iii) Publishers' Distributer Certificate / Authorized Dealership Certificate.
 - iv) Import / Export License.
 - v) Documentary proof of at least three reputed foreign publishers for importing books directly from them.
 - vi) Income Tax Return, Balance Sheet, Profit & Loss Account for the last three years.
 - vii) **Declaration Certificate:** Declaration Certificate that no case is pending with the police / court against the bidder / firm / company /Agency and not been suspended / blacklisted by any PSU / Government Department / Financial Institution / Court etc (as per annexure C).
 - viii) **No Deviation Certificate**: No Deviation Certificate as per format enclosed at **Annexure E**.

4. PROCEDURE FOR SUBMISSION OF TENDER:

Bidders are required to submit Bids in two parts viz. Technical Bid (Annexure-'A') and Financial Bid (refers to BoQ Online only) as per enclosed proforma along with supporting documents, application fee, EMD etc. The Tenderers are required to submit their tenders under 2 bid system with Cover-I (Technical Bid) and Cover-II (Price Bid).

A. Cover-I (Technical Bid)

(This cover shall contain): -

- (i) Annexure-'A' form duly filled along with relevant documentary proofs.
- (ii) Scanned copies of EMD in shape of CDR / FDR pledged to Accounts Officer, SMVDCS. Besides, the EMD in original shall be submitted alongwith the hardcopy of technical bid document.
- (iii) Tender Fee of Rs.500/- either in the form of DD pledged to Accounts Officer, SMVDCS, Katra or transferred in the official account of Shri Mata Vaishno Devi Charitable Society, Branch J&K Bank Katra in Account No. 50100417566279, IFSC – HDFC0002344(in IFSC Code "0" stands for Zero). The bidder shall mention UTR No. in the prescribed Technical Bid Form at Annexure- 'A'
- (iv) Tender Document containing <u>Instructions and Terms &Conditions</u>, <u>duly signed</u> on each leaf by the Tenderer, along with documentary proof wherever required.

B. Cover II (Price Bids):

- (i) The bidder shall have to quote net rate inclusive of all taxes / costs and F.O.R. site (Medical College, Kakryal / Non Engineering Store, Banganga) as per BOQ & has to submit online in the form of BOQ only.
- (ii) The price bid should be absolute and unconditional.
- (iii) Conditional bids shall be rejected.
- (iv) The price bids of only such bidders shall be opened, who qualify in the technical stage. Rates are required to be quoted in Indian Rupees only i.e. the rates of foreign publication shall also have to be quoted after converting to INR equivalence.
- (v) Price bids not conforming to above standards or suffering from any flaw shall be rejected.
- (vi) The bidders are also allowed to quote for **specific items of the BoQ** rather than having to compulsorily quote for **all the items of BoQ**.

5. **SELECTION CRITERIA:**

- i. In the first stage of evaluation, offer shall be rejected if found deficient as per the requirements of Tender / Bid Processing Fee and other eligibility criteria. Only bids confirming to the e-NIT conditions shall be further taken up for evaluation. Evaluation of the technical Bid will start first. The bidder qualifying the technical stage shall only be admitted in process of financial bid evaluation.
- ii. Financial bids of technically qualified bidders shall be opened and the bidder offering lowest rates shall emerge as L-1 bidder and shall be considered for the allotment of the contract. In-case of a tie in rates, revised sealed bid can be obtained on the spot and the bidder offering lowest rates shall be considered for the allotment of the contract. In-case of tie in second instance, it shall be decided by the process of "draw of lots".
- iii. The Shrine Board reserve the right to negotiate the quoted rates offered with the L-1 bidder or any of the other bidders on quality basis to ascertain the suitability of the offer for acceptance.
- iv. SMVDSB reserves the right to allot contract for supply of any books / journals to one or more bidders.
- v. <u>SMVSDB reserve the right to give counter offer of the offered rates to the bidders other than the L-1 bidder to bring them at the same rates as offered by the L-1 bidder.</u>

6. **PRE-BID CONFERENCE:**

A pre-bid conference will be held on <u>30.10.2024 at 12:00 Noon</u> at Conference Hall, Central Office, SMVDSB, Katra. In case, any of the prospective bidder(s) intends to join the pre-bid conference through online mode, they shall forward their request on the official e-mail ID nes_purchase@maavaishnodevi.net by or before 28.10.2024. Shrine Board reserves the right to modify the terms & conditions of e-NIT after the pre-bid conference in view of any practical modalities which may emerge during the pre-bid meeting.

7. **GENERAL TERMS & CONDITIONS:**

- (i) The bidder shall offer the lowest rates for Books / Journals to the SMVDSB.
- (ii) The Technical Bid should be accompanied by a copy with each page duly signed by the authorized signatory of the bidder (s), who has signed the tender document, as a token of acceptance of the terms and conditions of the e-NIT otherwise, bid(s) shall not be considered.

- (iii) Any changes/corrigendum/extension of closing / opening dates in respect of this e-NIT shall be issued through SMVDSB's website, or e-publishing portal only and no press notification will be issued in this regard. The bidder(s) are therefore requested to regularly visit SMVDSB's website and e-publishing portal for updates.
- (iv) The quantity of items mentioned in Annexure-D may increase / decrease while placing the order.
- (v) In case of rejection of the bid(s) due to incomplete information or not meeting the terms & conditions mentioned in e-NIT, the competent authority's decision will be final and the party shall not be entitled to any compensation for non-issue of work.
- (vi) In case any document attached is found forged/tampered, the bidder (s) is likely to face legal action under rules including forfeiture of their earnest money and debarring to participate in the future tenders process of SMVDSB for a period of 03 years.
- (vii) After successful culmination of tender process, if the approved bidder refuses to comply with the rate approval order and subsequently fails to comply the supply orders on account of any reason, the bidders shall be debarred from further dealing with the Board for a continuous period of 03 years and the stipulated CDR/FDRs of the bidder shall be forfeited.
- (viii) SMVDSB reserves the right to seek clarifications or additional information/documents from any bidder regarding its technical bid. Such clarification(s) or additional information/document(s) shall be provided within the time specified for the purpose. Any request and response thereto shall be in writing, if the bidder does not furnish the clarification(s) or additional information/document(s) within the prescribed date and time, the proposal shall be liable to be rejected.
- (ix) SMVDSB is not bound to award contract at the lowest rates offered/ quoted in the Tender and reserves the right to decide on fair and reasonable price of the services goods tendered. All other terms and conditions of the tender shall remain operative even if a counter offer rate is offered to the bidders.
- (x) SMVDSB reserves the right to engage one or more agencies at a time. One or more agencies may be selected through this Tender. Those agencies who accept the offer will be selected for supply of books / journals from time to time to the SMVDSB.
- (xi) It is clearly understood by the parties that no financial liability of any type is created by issuance of the letter of Award.
- (xii) SMVDSB reserves the right to modify/change/delete/add any further terms and conditions prior to the issue of work order.

(xiii) TERMS OF CONTRACT

- a) Period of Contract: Contract period will be <u>initially for one year and extendable by another one year on same rate and terms & conditions subject to mutual acceptance.</u>
- b) The offered rates shall remain unchanged during the entire period of Contract.
- c) **Sub-Contracting**: The successful bidder shall not assign, sub-contract or sublet the whole or any part of the contract in any manner.
- d) The SMVDSB will have the right to drop any Agency without assigning any reason whatsoever. SMVDSB also reserves the right to modify the Terms and Conditions of the e-NIT.

- e) No banned book(s) / journal(s) should be supplied even if the same is ordered and if any such book / journal is supplied, it would be forfeited.
- f) **Delivery Period**: The successful bidder has to execute all the supplies within the stipulated time frame (60 days in case of Foreign Books / Journals and 30 days in case of Indian Books / Journals) from the issue of each Supply Order during the period of Rate Contract.
- g) The list of books is mentioned in Annexure-D. It is to be ensured that a minimum of 95% supply of books / journals from the annexed list shall be made within 40 days in case of Foreign Books / Journals and 20 days in case of Indian Books / Journals from the date of placement of Supply Order.
- h) Damaged books / journals or books journals with missing pages shall under no circumstances be accepted by SMVDSB and should be taken back by the successful bidder even after they have been stamped for accessioning at its own expenses.
- i) The latest paperback editions should always be supplied unless otherwise mentioned. Indian reprints/editions, if available should be supplied. Librarian of SMVDIME Medical College should be consulted beforehand if successful bidder intends to supply hardback editions, if the ordered paperback edition is not available.
- j) Only Paper Back edition would be supplied, wherever available. If "Paper Back editions are not supplied a certificate would be submitted stating that "No paperback edition for the book(s) /journal(s) [mentioned name of title(s)) is/are available." The Books / Journals must be of latest edition.

8. **PENALTY:**

Following penalties shall be imposed for delay beyond the prescribed delivery period, subject to acceptance by the Competent authority of SMVDSB: -

- a) upto 7 days @ 0.5%
- b) From 8th day to 15th day @ 1%
- c) From 16th day to 22nd day @ 1.5% and
- d) From 23rd day to 30th day @ 2% shall be imposed on each pending item as per the approved rate/quantity mention in the purchase order of the value of the pending supplies.
- e) In case of incomplete supply received, an amount equal to 2% of the total value of non-supplied material shall be deducted from the due payment of the supplier.

9. **BILLING AND PAYMENTS:**

No advance payments shall be made: - The payment shall be made after the supply and acceptance of books / journals in good conditionby the institute, within a period of 30 days from the date of receipt of books / journals. Further, TDS/Income Tax etc. shall be deducted at source from the bills as per rules in vogue.

10. THE BILL MUST MENTION THE FOLLOWING:

- i. The latest edition/ordered edition of the books / journals have been supplied. No "Remaindered" title is supplied.
- Ref. No & Date/ ISBN/ Author/ Title/ Publisher/ Currency / Qty / Price / Gross / Dis. (%) / Net Amount.
- iii. The bill must contain the item number of the order against the title supplied.

11. INSPECTION / LIFTING BACK OF REJECTED SUPPLIES:

- The supplied Books / Journals shall be checked / inspected by the team nominated by the authorities and if found defective or not as desired, the same shall be rejected.
- ii. The rejected material shall have to be lifted by the supplier at his own risk and cost within a week's time, failing which storage charges per day as may be deemed fit shall be levied.

iii. In case supplies are rejected, same shall be lifted back by the supplier within 07 days from the date of intimation from this office, failing which the penalty @ 2% of the total value of rejected supplies per day shall be imposed against the supplier for a period of one week which shall be doubled in subsequent weeks and the rejected material in the stores shall be at the risk of the firm. Beyond one month the material shall be auctioned and storage charges shall be recovered from the supplier @2% per day. The amount acquired on account of auctioning shall be deposited to SMVDSB Account.

12. **TERMINATION OF CONTRACT:**

Either Party may terminate the Contract by giving 2 months notice. Further, the contact can also be terminated by SMVDSB at any time in case the services are not found "satisfactory".

13. Shrine Board reserves the right to alter, accept or reject part or all the Tenders without, assigning any reason thereof.

14. **ARBITRATION:**

All disputes and differences between the parties hereto shall be referred to the sole arbitration of the person to be nominated and appointed by the **Chief Executive Officer**, **Shri Mata Vaishno Devi Shrine Board**, whose decision shall be final and binding upon the parties to this agreement. The provision of The Arbitration and Conciliation Act, 1996 shall apply and seat of arbitration shall be at Jammu. Courts at Katra and Reasi only shall have the jurisdiction to entertain any legal proceeding arising out of this contract.

15. **FORCE MAJEURE:**

Any failure or omission to carry out the provisions of the order shall not give rise to any claim by one party against the other, if such failure or omission arises from an "Act of God" which shall include all acts of Natural Calamities such as fire, flood, earthquakes, hurricanes or any pestilences or from civil strikes, compliances with any statute or regulations of the Government lock outs and strikes, riots, embargoes or from any other reasons beyond the control of the parties including the war (Whether declared or not) Civil War or State of Insurrection.
