The Manufacturers/Dealers/Companies/Firms should have a minimum of 2 years manufacturing/selling/operating experience in Electric Vehicles with annual turnover of atleast Rs. 2.00 Crore per annum during last three years and a sound professional track record.

Expression of Interest

Expression of Interest is hereby invited from the reputed/registered Manufacturers/Dealers/Companies/Firms for selection of Electric Vehicles (Pollution free vehicles) which shall ply between Adhkuwari to Bhawan via Himkoti Marg and vice-versa for carrying pilgrims visiting the holy Shrine for paying obeisance to the Deity.

1. Introduction:

With a view to facilitate the pilgrims visiting the Holy Shrine of Shri Mata Vaishno Devi Ji especially those who are aged, handicapped, infirm and unable to negotiate the steep climb on the hilly terrain, Shri Mata Vaishno Devi Shrine Board had introduced Electric Pollution Free Vehicles for ferrying the pilgrims from Adhkuwari to Bhawan and back via alternate track namely 'Himkoti Marg'.

Interested Manufacturers/Dealers/Companies/Firms of Electric Vehicles can submit their offer for the Electric Vehicles which is suitable for the intended operations and comply with the specifications as mentioned in the Clause No. 02 of this Eol.

This Eol is only for selection of Electric Vehicles which shall ply on Himkoti Marg for ferrying of Pilgrims from Adhkuwari to Bhawan and back. The vehicles selected under this Eol shall be put on trial on the aforesaid Marg/Track to test its efficiency/feasibility/reliability through a Committee.

On the basis of selected Electric Vehicle, an e-NIT shall be floated for selecting the Service Provider who shall have to enter into a contract with the Shrine Board for providing services of Electric Vehicles (Pollution free vehicles) from Adhkuwari to Bhawan and back for the pilgrims visiting the Holy Shrine for paying obeisance to the Deity.

Note: This Eol is not a tender and the sole purpose is to select required Electric Vehicles (Pollution free vehicles) by the Shrine Board.

2. Desirable/essential requirement of Electric Vehicle:

- A. To ferry a minimum of six plus passengers and above (excluding driver) from Adhkuwari to Bhawan and back (Approx. 6:5 Kms one way).
- B. Atleast 08 trips (per side) per vehicle in a day shall be required to be undertaken.
- C. EV must be equipped with GPS, CCTV camera with video recording facility & high resolution display screen.
- D. EV should be registered with Registration Authority of Vehicles.
- E. EV should be a light weight car with covered roof & sides (windows) for all weather plying.



- M. The proposed EV must be able to comfortably negotiate the track from Adhkuwari to Bhawan.
- N. Interested Manufacturers/Dealers/Companies/Firms shall offer Electric Vehicle of leading brands (Company Made) only. Any modified version of the original Model shall not be entertained.
- O. The proposed Electric Vehicle must be plying commercially on road for atleast one year upto 31.01.2024 and without any record of manufacturing / engine related accident(s).
- P. The launch date of the EV must not be prior to 01.01.2021.
