However, Donations to Shri Mata Vaishno Devi Shrine Board, Katra are exempted from Income Tax under section 80-G of the Income Tax Act.

Your sealed quotations addressed to Dy. Chief Executive Officer (V), Shri Mata Vaishno Devi Shrine Board, Central Office, Katra should reach through Speed Post / Registered Post / reputed courier or be personally handed over to the Purchase Section on or before **21.06.2024 upto 05:00PM** positively. Quotations after due date and time and without samples shall not be accepted.

Terms and Conditions:

- This is just a RFIQ and not a Purchase Order.**
- Rate should be NET inclusive of all taxes, having special discount to SMVDSB and the same shall be delivered at Non-Engineering Store, Banganga, Katra within the period mentioned in the subsequent Purchase Order. However, Donations to Shri Mata Vaishno Devi Shrine Board, Katra are exempted from Income Tax under Section 80-G of the Income Tax Act.
- The rate quoted should be NET and valid for a period of 20 days from the date of Opening of quotation and should be valid for a period of Six Month from the date of issuance of Rate Approval Order /1st supply Order. The Rate approval order is extendable for another period of (03) Month on the existing approved rates, terms and conditions, subject to satisfactory supply of aforesaid Spices.**
- You are requested to send your sealed quotations by or before **21.06.2024 upto 05:00PM**, quotations after due date and time shall not be accepted.
- The participating firm shall have to submit sealed sample of above referred items alongwith sealed quotation without which the offer submitted by the participating firm shall not be considered.**

The participating firm must fulfilled the following Criteria:-

- a. The firm (Manufacturer/Authorized supplier) should have regularly for at least last three years ending 31st March of the previous financial year, supplied the material mentioned in the RFIQ (supply orders to be attached.)
 - b. The firm should have manufactured or supplied at least 60% of the estimated quantity of the product in at least one of the last five (05) years ending 31st March (supply order to be attached).
 - c. The firm must have an annual capacity to supply at least estimated quantity and above (self certificate to be attached).
7. The approved firm shall have to deposit Earnest Money in the form of CDR / FDR pledged to FA/Chief Accounts Officer, SMVDSB, Katra amounting to Rs.10,000/- (Rupees Ten Thousand only) against for the supply of above referred Masala items drawn from any Nationalized / scheduled Bank having validity of 12months shall be furnished before placing rate approval order
 8. If the any firm withdraws his offer before the expiry of the said period or makes any modifications in the terms and conditions of the Purchase Order, the earnest money/security deposited by the tenderer shall be forfeited without anynotice.
 9. If the successful firm fails to abide by the terms and conditions of the RFIQ / Purchase Order or did not supply the material, the earnest money/security deposited by the tenderer shall be forfeited without any notice.
 10. Rate should be Net inclusive of all taxes, having special discount to SMVDSB (if any) and the same shall be delivered at Non Engg. Store, Banganga, Katra. The supplier has to mention the price of the material, CGST & SGST separately while raising the bills of supplies.
 11. The rates should strictly be quoted on the format enclosed with RFIQ and as per the specification / UOM / requirement. Any deviation from the same shall tantamount to rejection of the offer / rates quoted by you.
 12. The quantities mentioned in the format are indicative in nature and can be increased / decreased substantively according to the requirement from time to time during the rate approval period.
 13. Shrine Board Reserves the right to split the demand among one or more firms on quality basis to ascertain the suitability of the acceptable offer.
 14. Shrine Board Reserves the right to cancel the RFIQ without any prior notice.
 15. No Advance payment shall be made. The payment shall be made and after receipt and proper inspection of complete material at Non Engineering Store, Banganga.
 16. The Shrine Board reserves the right to negotiate the quoted rates, terms and conditions with the lowest bidder or any of the other bidder on quality basis to ascertain the suitability of the acceptable offer.
 17. On receipt, the material shall be inspected / checked by our Inspection Committee and if found of inferior quality/defective, the same will be rejected and the Board shall be at liberty to have the same procured from open market at the risk & cost of the supplier whereby the original supplier shall be liable to pay the extra cost, if any, involved in the process. The Competent Authority, however, may accept the replaced material within the delivery period if it conforms to the approved specifications.
 18. In case of incomplete supply, an amount equal to 2% of the total value of work shall be deducted from the due payment of the supplier.
 19. The Shrine Board reserves the right to reject, accept or prefer any quotation in part or full at any stage if not in conformity to the quality, terms & conditions mentioned in the RFIQ. Shrine Board also reserves the right to re-invoke the RFIQ at its sole discretion.
 20. Conditional, illegible, ambiguous quotation(s) and quotation(s) received after the stipulated date and time shall be out rightly rejected.
 21. The other terms and conditions shall be reflected in the supply order.
