**SUBJECT:** e-Auction Notice inviting bids for the Auction of “Discovery NM 630 Dual Head Gamma Camera on As Is Where Is Basis”.

**1. REQUIREMENT:**

For and on behalf of Shri Mata Vaishno Devi Charitable Society, interest of bidders is invited for participating in the process of e-auctioning of “Discovery NM 630 Dual Head Gamma Camera on As Is Where Is Basis”. The detailed Tender Document with full description and Terms and Conditions is available at [www.maavaishnodevi.org](http://www.maavaishnodevi.org)

**2. INTRODUCTION OF MEDICAL EQUIPMENT:**

The Dual Head Gamma Camera Discovery NM 630 (with all accessories and CMC for 10 years) was procured in September, 2016 from M/s Wipro Healthcare Pvt. Ltd. by **Shri Mata Vaishno Devi Institute of Medical Excellence** and installed at the **Shri Mata Vaishno Devi Narayana Superspeciality Hospital (SMVDNSH), Kakryal**. The SMVDIME / SMVDNSH are now part of the Shri Mata Vaishno Devi Charitable Society. The equipment is well maintained and is in exceptionally good functional condition. The details of equipment are further captured in “Annexure-D”

**3. SCHEDULE of e-Auction:**

**4. ELIGIBILITY CRITERIA:**

- a) The bidder should be registered as (proprietorship / partnership / firm or company) with any Government Authority (copy of the same must be attached).
- b) The bidder shall compulsorily submit a copy of acceptance from the competent Government authority for decommissioning, packaging, transport and safe disposal of radio-active material. Besides, the bidder must be eligible entity in terms of compliance to guidelines for handling of radio-active materials including packaging, transportation etc.
- c) **The bidder shall submit a detailed plan for decommissioning, packaging, transport and safe disposal of radio-active material, besides security as per the ELORA / AERB guidelines. In addition, the following documents shall be needed to be attached:**
  - i. **Details of source housing / container showing the position of the source with diagram / sketch along with procedure for retrieval of the source.**

- ii. **Details of the package in which radioactive material is proposed to be transported along with the blue print or sketch showing all the dimensions including shielding details.**
  - iii. **Security plan for the facility as per AERB safety guide on 'Security of Radioactive Material during Transport' (AERB/NRF-TS/SG-10).**
  - iv. **An undertaking to the effect that the successful bidder shall comply with all requirement as per AERB / ELORA guidelines (Annexure-C)**
- d) The bidder shall submit a copy of concurrence from the concerned Government agency for accepting the disused radio-active source.
  - e) The bidder shall submit an affidavit duly attested by 1<sup>st</sup> Class Magistrate, indemnifying seller from any mishandling, damages and non-compliance of any ELORA/ AERB guidelines. The successful bidder shall be entirely responsible for any loss(es), damages etc. suffered by or any injury sustained by the labourer; within the SMVD premises or otherwise. In any circumstances, bidder shall not be entitled for any claim in this regard. The bidder or his labourer shall not be permitted to stay in the SMVDNSH premises beyond working hours of the SMVDNSH, Kakryal.
  - f) The bidder must attach the copy of PAN card and GST registration certificate.
  - g) The bidder must submit the copy of this e-auction document with each page signed in token of acceptance of all terms and conditions.
  - h) The bidder must submit the copy of depositing of the tender fee and EMD in the shape of CDR / FDR / TDR pledged to Accounts Officer, SMVDCS in original, along-with the technical bid document.

5. **PROCEDURE FOR SUBMISSION OF TENDER:**

Bidders are invited to submit their interest for participation in e-auction for sale of **"Discovery NM 630 Dual Head Gamma Camera on As Is Where Is Basis"** as per Technical Bid format (**Annexure-'A'**) along with supporting documents mentioned at Conditions 4 above. The technically qualified bidders only shall be allowed to take part in the financial bidding.

6. **PRE-BID CONFERENCE:**

A pre-bid conference will be held on **29.05.2025 at 12:00 Noon** at Conference Hall, C.O., Katra. The prospective bidders are requested to preferably send their queries at-least 02 days in advance before scheduled pre-bid meeting on e-mail ID nes\_purchase@maavaishnodevi.net. Further, in case, any of the prospective bidder(s) intends to join the pre-bid conference through online mode, they shall forward their request on the official e-mail ID nes\_purchase@maavaishnodevi.net by or before 28.05.2025. **Shrine Board reserves the right to modify the terms & conditions of e-auction notice after the pre-bid conference in view of any practical modalities which may emerge during the pre-bid meeting.**

7. **SELECTION CRITERIA:**

- i. In the first stage of evaluation, technical offers shall be rejected if found deficient as per the requirements of e-auction notice / Bid Processing Fee and other eligibility criteria. Only the bids that conform to conditions of e-auction notice shall be further taken up. The bidder qualifying the technical stage shall only be allowed to participate in the process of auctioning (financial part).
- ii. The bidders should carefully study the auction document before submission of their bids. They should fully acquaint themselves with site conditions / condition of equipment and all other factors which may influence the amount to be offered in auction.
- iii. The bidder can inspect the medical equipment on any convenient date & time during the time window and other details given below:

**8. GENERAL TERMS & CONDITIONS:**

- (i) The Technical Bid should be accompanied by a copy of this e-auction notice with each page duly signed by the authorized signatory of the bidder (s), who has signed the tender document, as a token of acceptance of the terms and conditions of the e-auction otherwise, bid(s) shall not be considered.
- (ii) The bidder can inspect the medical equipment in-person at SMVDNSH in the time-window specified in the notice.
- (iii) Any changes/corrigendum/extension of closing / opening dates in respect of this e-auction shall be issued through **SMVDSB's website** only and no **press notification will be issued in this regard. The bidder(s) are therefore requested to regularly visit SMVDSB's website** for updates.
- (iv) In case of rejection of the bid(s) due to incomplete information or not meeting the terms & conditions mentioned in e-auction notice, the competent authority's decision will be final and the party shall not be entitled to any compensation for non-issue of work.
- (v) In case any attached document is found forged/tampered, the bidder (s) is likely to face legal action against them under rules including forfeiture of their earnest money and debaring to participate in the future auctioning / tendering process for a period of 03 years.
- (vi) After the successful culmination of tender, if the approved bidder(s) refuses to execute the obligations in its scope, he / it shall be debarred from further dealing with the Board for a period of 03 years and the EMD of the bidder shall be forfeited.
- (vii) SMVDCS reserves the right to seek clarifications or additional information / documents from any bidder regarding its technical bid. Such clarification(s) or additional information/document(s) shall be provided within the time specified for the purpose. Any request and response thereto shall be in writing, if the bidder does not furnish the clarification(s) or additional information/document(s) within the prescribed date and time, his / their proposal is liable to be rejected.
- (viii) It is clearly understood by the parties that no financial liability of any type is created by issuance of this e-auction notice.
- (ix) SMVDCS reserves the right to modify/change/delete/add any further terms and conditions prior to the issue of Letter of Award.
- (x) The SMVDCS will have the right to drop any bidder without assigning any reason whatsoever. SMVDCS also reserves the right to modify the Terms and Conditions of the e-auction notice.
- (xi) The Competent Authority reserves the right to accept or reject any offer in part or in full without assigning any reasons thereof.
- (xii) **The bidder shall be selected on the basis of highest offered single consolidate amount (including GST and other applicable taxes) for the entire task including decommissioning, transportation, packaging etc.**

- (xiii) The successful bidder shall have to deposit full committed (auction) amount including GST as applicable in the Accounts Section, Shri Mata Vaishno Devi Charitable Society, Katra within a period of 10 days from the date of issuance of Letter of Award (LoA). Thereafter, the successful bidder(s) shall have to lift the equipment on "as is where is basis" from SMVDNSH, Kakryal within a period of 20 days from the date of deposit of full quoted amount. Failing to deposit the full quoted amount within 10 days from the date of LoA or lifting the equipment within 20 days from the date of deposit of the full quoted amount, the contract shall be terminated and EMD shall be forfeited, besides debarring the bidder from participating the Shrine Board tendering / auction process for the next 03 years.
  - (xiv) The EMD of the successful bidder shall be released within 15 days of date of lifting of Discovery NM 630 Dual Head Gamma Camera and that of the unsuccessful bidder shall be released within 15 days of the conclusion of e-auction.
  - (xv) All taxes including GST; as applicable, shall be in the scope of successful bidder.
  - (xvi) Loading / unloading of material shall also be in the scope of successful bidder.
  - (xvii) During packing / transportation of medical equipment, it shall be ensured that an authorized official from the SMVDIME is compulsorily present. Besides, the presence of a representative of authorized agency under ELORA / AERB (if prescribed under the guidelines) shall be essential.
9. Shri Mata Vaishno Devi Charitable Society reserves the right to alter, accept or reject part or all the Tenders without, assigning any reason thereof.
10. Unless the context requires otherwise, the reference of words 'Shrine Board' or 'Shri Mata Vaishno Devi Shrine Board' or 'SMVDSB' shall be interpreted as 'Shri Mata Vaishno Devi Charitable Society' on behalf of which this e-auction is being carried out.
11. **TERMINATION OF CONTRACT:**  
If the successful bidder fails to execute the contract within the stipulated time or violates the terms and conditions of the e-auction, the LoA issued may be cancelled by the competent authority. In such an eventuality, no compensation / damages, whatsoever shall be payable to the successful bidder.
12. **ARBITRATION:**  
In case of any dispute arising between the parties in respect of any connected matter, both parties shall make every effort to resolve it amicably by direct informal negotiation. If, even after thirty days from the commencement of informal negotiation, the parties are not able to resolve the dispute amicably, then such disputes / differences shall be resolved by Arbitration as per the Arbitration and Conciliation Act, 1996.
- a) Either party may request other of its intention that a dispute be submitted to Arbitration and both the parties shall meet within 15 days from the date of receipt of such request, to select a sole arbitrator mutually for the resolution of dispute and venue. The seat of Arbitration shall be at Jammu /Katra / Reasi.
  - b) In the event that the parties cannot agree upon the selection of the sole Arbitrator, either party or both of the parties may move an application before the Hon'ble High Court at Jammu, under the Arbitration and Conciliation Act, 1996, for the appointment of sole Arbitration with seat / venue at Jammu for the resolution of disputes between the parties.

However, on failure of resolution of disputes through procedure elaborated above, the Courts at Katra / Reasi alone, shall have the Jurisdiction with respect to subject matter of this e-auction notice.

13. **FORCE MAJEURE:**

Any failure or omission to carry out the provisions of the order shall not give rise to any claim by one party against the other, if such failure or omission arises from an "Act of God" which shall include all acts of Natural Calamities such as fire, flood, earthquakes, hurricanes or any pestilences or from civil strikes, compliances with any statute or regulations of the Government lock outs and strikes, riots, embargoes or from any other reasons beyond the control of the parties including the war (Whether declared or not) Civil War or State of Insurrection.
