Detailed terms and conditions to Auction Notice No.To/TPT/K/529 dated:-08-07-2024.

4. The SMVDSB auction committee reserves the right to accept/reject any bid (including highest bid) without assigning any reason thereof.

6. The SMVDSB may impose/relax any condition and announce the same at the time of auction.
